




Fig. 2. Construction du système ville (B. Boissacot-Camus, G. Djawant, B. Dufaj, H. Galinier, C. Grataloup, C. Guillemeau, X. Rodier).







Fig. 4. Schématisation : comparaison de Tours et Poitiers au X<sup>e</sup> siècle (B. Boissavitt-Carnus, G. Djawent, B. Dufay, H. Galinié, C. Grataloup, C. Gailloteau, X. Rofier).



1 même chorotype





Fig. 5. Processus de modélisation (B. Boissier-Camus, G. Djament, B. Dufay, H. Galinié, C. Gratoloup, C. Guillaume, X. Rodier).
